

## **CONDITIONS OF ENTRY**

- 1. Competition is only open to amateurs who are 19 years of age or under. The term "Amateur" means one whose principal source of income is not derived from the exercise of his or her talent in the particular class for which he or she may have entered. This condition does not apply to conductors or accompanists.
- 2. No entry will be accepted unless accompanied by full fee and the committee reserves the right to refuse any entry.
- 3. Solo Competitors can compete only once in a section unless playing from a different family of instruments.
- 4. In sections for duets and groups, no competitor shall compete with more than one party in a particular section, unless playing from a different family of instruments.
- 5. The committee reserves the right to transfer competitors to the section above or below in Own Choice sections where there are insufficient competitors to constitute an event.
- 6. It is the competitor's responsibility to see that they have correct set pieces, edition and setting as stated in the schedule of competition, otherwise competitors will be disqualified.
- 7. All accompaniments must abide by individual section rules please check your section in regards to what is deemed appropriate. Unless otherwise stated, all sections are to be performed with accompaniment. This may be: Acoustic accompaniment (eg piano, ukulele, guitar etc). One instrument only. There will be no facilities for instruments to be electrified in solo sections for the use of accompaniment .
- 8. Competitors, accompanists, etc must be present at the time specified for the item in which they are competing and assemble at the place specified by the Chairman of Sessions.
- 9. Competitors will compete in the order as shown in the program unless instructed otherwise by the Chairman of Sessions.
- 10. The Executive reserves the right to amend the printed program should it be considered necessary.
- 11. OWN CHOICE: Marks will be awarded for quality of selections. No competitor may use the same Own Choice in more than one section. Competitors may not use an Own Choice selection with which he or she has gained a prize during the 2019 Bundaberg Eisteddfod. A Set Piece may not be used as an Own Choice selection. Competitors can perform a piece only once in the eisteddfod.
- 12. Do not submit originals for Own Choice work as all copies will be destroyed by the Committee after each session.
- 13. Any competitor who does not submit a copy of their Own Choice selection can still perform but WILL NOT be eligible for any placing. An adjudication will still be provided.
- 14. Anyone experiencing difficulty in obtaining set music pieces should email <u>be@bundabergeisteddfod.com.au</u> and your email will be forwarded to the appropriate person/s.
- 15. No parent, teacher, conductor or competitor may address the adjudicator before or during a session.
- 16. No parent shall be allowed on the performing area, except as accompanist or conductor.





## CONDITIONS OF ENTRY CONT.

- 17. The Adjudicator's decision shall be final, except if it subsequently transpires that some error in identity has taken place, then the Executive shall have the power to decide.
- 18. Protests must be lodged in writing with the Secretary within 30 minutes of the cause of such protest arising, accompanied by a fee of \$5-00 which will be forfeited if the protest be deemed frivolous. The decision of the Eisteddfod Committee executive is final.
- 19. No prize will be awarded where the Adjudicator considers merit insufficient.
- 20. No ties will be awarded. A 1st and 2nd and 3rd (and highly commended award/s) where the adjudicator feels it is warranted.
- 21. In sections with three or fewer competitors, the adjudicator may decide to award only one prize.
- 22. All competitors will receive an adjudication sheet.
- 23. Vocal solos and duets in all age groups may be sung in any key and transposed if necessary.
- 24. There will be only one clear-cut winner for Special awards.
- 25. Time limits: Please refer to your individual section rules. These are non-negotiable.
- 26. It is the parents' responsibility to inform the Committee if they do not wish their child to be photographed for possible media publication.
- 27. Competitors should avoid the use of words that are not regarded as acceptable in a family group or polite society. Contestants using 'unacceptable' words could face disqualification.
- 28. Competitors must perform within the section as scheduled in the program.
- 29. Novice Definition: competitors who have been learning on their nominated instrument for 18 months or lesson and have not placed previously in any section of the music eisteddfod.
- 30. Competitors in the 2022 Bundaberg Regional Eisteddfod, will perform
- (a) From an original published edition of the sheet music: or
- (b) From a photocopy, transcription or arrangement of sheet music that is accompanied by a letter from the music publisher authorizing the use of this photocopy, transcription or arrangement: or
- (c) From sheet music where both the work and edition are out of copyright\* or
- (d) By ear. \*Composer/lyricist/arranger ALL died before 1955 and the edition publication date was more than 25 years ago.
- 31. The Committee will not be liable for any copyright infringements relating to the use of photocopies should they occur.
- 32. The Committee reserves the right to split/combine sections where applicable dependant on the number of entrants in each section



# BUNDABERG REGIONAL EISTEDDFOD INC CODE OF CONDUCT

## **PREAMBLE**

The Code of Conduct is a set of rules outlining the social norms and responsibilities of, or proper practices for an individual, party or organization. The code clarifies an organization's mission, values and principles, linking them with standards of professional conduct.

Our eisteddfod recognizes the importance of, and responsibility for, ensuring our event is a safe, supportive and enriching environment which respects and fosters the dignity and self-esteem of children and young people, and enables them to thrive in their artistic and performance endeavours.

**OBJECTIVE:** To maintain ethical conduct, by adhering to the basic principles of humanity:-Positivity – Fairness – Respect.

**ACTION:** Competitors, teachers and parents accept that 'fair play' includes acceptance and observance of the Bundaberg Regional Eisteddfod rules and conditions and that the adjudicator's decisions are final.

ASPIRATION: Fairness, respect and good sportsmanship implies maturity and courage.

**AIMS:** The Code of Conduct aims to ensure that the Bundaberg Regional Eisteddfod will be a positive experience for competitors who become involved.

**CONSEQUENCE:** Breaches to any of the behaviours listed will result in a warning and/or being asked to leave the auditorium depending on the severity of the breach. Consistent breaches of the listed behaviours over several sessions may result in a ban from the Eisteddfod event.

Appropriate behavior/conduct should be displayed towards committee members, fellow competitors, the adjudicator and volunteers.

Inappropriate behavior/conduct in this instance is defined as unsportsmanlike actions through verbal or written comments, isolation or bullying behavior – this encompasses emotional and physical acts and loud or obnoxious language and behavior (both within and out of the venue). It also includes all social media.

**POSITIVITY:** There is the expectation that all associated with the Eisteddfod will represent themselves in a positive manner. Entrants should perform to the best of their ability. Teachers, competitors, parents, Committee members and volunteers are to maintain high levels of self-respect and appreciation of the Eisteddfod formalities and traditions. In winning or in defeat, competitors, parents and teachers will accept both in a dignified and respectful manner — with recognition that the adjudicator's decision is final and that the rules of the Eisteddfod have been adhered to.

**FAIRNESS:** Competitors and teachers must always conduct themselves in a civil and sporting manner – before, during and after competition. Unsporting behaviour includes, but is not limited to - foul, rude or abusive language in any context: threatening or intimidating conduct, discourteous gestures, excessive celebration of success or violent actions of any degree or kind.

Competitors and teachers promote fairness by not allowing or encouraging family or friends to hinder the Committee's ability to marshall competitors or manage the competition.

**RESPECT:** Respect as an underpinning principle is demonstrated by taking positive notice of, giving special consideration and attention to, and regarding as worthy the following:

- Endeavours of other competitors and teachers Being inclusive and the rights of all to participate without prejudice or discrimination.
- The judgment of adjudicators and their written critiques: the application of the rules before, during and after the Eisteddfod.
- Activities of Committee members, volunteers and others who oversee the day to day running
  of the Eisteddfod.

## **FAILURE TO MAINTAIN ETHICAL CONDUCT**

## **Zero Tolerance**

The Committee of the Bundaberg Regional Eisteddfod Inc will not tolerate any "unacceptable conduct" (including but not limited to verbal abuse of any person, obscene language, loud or boisterous conduct), which is deemed unacceptable by the Committee. This includes all persons attending at any venue of the Eisteddfod.

# Refusal of a Directive

Any member of the Committee or designated official may give a directive at any time to any person to whom this code applies to ensure the smooth and efficient running of the Eisteddfod and any person who refuses to obey such directive may be asked to leave a venue and failure may result in the Committee taking such action, including the calling of police to ensure the Eisteddfod's unimpeded operation.

# **Equipment Damage**

Any person using the equipment owned by, leased or hired by the Bundaberg Regional Eisteddfod Inc are responsible for:-

Any damage caused to that equipment.

Any damage howsoever caused to that equipment and further any person deliberately damaging Eisteddfod equipment will be responsible for the replacement of that equipment or the payment of the cost of same.

# **Behaviour**

Any person behaving in a manner as deemed by the Committee or representative of same to be unacceptable, will be removed if it be deemed appropriate by the official. If that person is a competitor they may be disqualified from competing in that section and other sections.

## **GUIDELINES**

To meet the above criteria the following specific rules and consequences apply:-

- Knowingly damaging venue property may result in the person responsible being financially liable for the damage or being at risk of being charged with vandalism.
- Verbally abusing Eisteddfod volunteers, venue staff or other competitors, teachers, parents
  and supporters such as making put down remarks, use of obscene language in a yelling and
  insulting manner, accusations, threats to physical, psychological or emotional safely will result
  in the person being asked to leave the venue immediately.
- Threats to the safety of any other person or any physical abuse will result in the abuse being reported to police and charges may be laid
- Put downs of other competitors or their teachers or criticism of adjudicators or their
  adjudications made between parties loud enough that the comments can be heard by other
  venue users will result in the person given warning. Further breaches may result in the
  person being asked to leave the venue.

# CHILD SAFETY, CODE OF CONDUCT

**OBJECTIVE:** To ensure the safety and wellbeing of children and young people. Our Eisteddfod recognizes the importance of, and a responsibility for, ensuring our event is a safe, supportive and enriching environment which respects and fosters the dignity and self-esteem of children and young people, and enables them to thrive in their artistic and performance endeavours.

**ACTION:** Report any allegations of child abuse or other child safety concerns to the Committee. Ensure as quickly as possible that participants are safe and protected from harm, if child abuse is suspected. The Eisteddfod Office bearers and Committee will also provide information and support to enable the Code of Conduct to operate effectively.

# **Child Safety**

This Code of Conduct aims to protect children and reduce any opportunities for child abuse or harm to occur. It also assists in understanding how to avoid or better manage risky behaviours and situations. It is intended to complement child protection legislations and event policies and procedures. These apply to Committee members, Teachers, Parents, Competitors and Volunteers.

All involved in the conduct of the Bundaberg Regional Eisteddfod are required to comply with the Code of Conduct by observing expectations for appropriate behavior below. The Code of Conduct applies in all situations, including relationships and communications with Audience, Entrants, Teachers and Parents as well as in preparation/change areas and the performance space.

# **Acceptable Behaviour**

- Upholding the Eisteddfod's statement of commitment to child safety always and adhering to
  the event's child safe policy treating competitors, teachers and families involved in the event
  with respect, both within the theatre environment and outside as part of normal social and
  community activities.
- Listening and responding to the views and concerns of our participants, particularly if they are telling us that they or another child has been abused or that they are worried about their safety/the safety of another child.
- Promoting the cultural safety, participation and empowerment of Aboriginal and Torres Strait Islander participants, students with culturally and /or linguistically diverse backgrounds and participants with a disability.
- Ensuring that written texts and songs be age appropriate.

# **Unacceptable Behaviour**

- Ignore or disregard any concerns, suspicions or disclosures of child abuse.
- Develop a relationship with any participant that could be favouritism or amount to 'grooming' behavior (for example offering gifts).
- Exhibit behaviours or engage in activities with participants which may be interpreted as abusive and not justified by the performance or service delivery context.
- Ignore behaviours by other adults towards participants when they appear to be overly familiar or inappropriate.
- Discuss content of an intimate nature or use sexual innuendo with participants.
- Treat a child unfavourably because of their disability, age, gender, race, culture, vulnerability, sexuality or ethnicity.
- Communicate directly with a participant through personal or private contact channels (9including by social media, email, instant messaging, texting etc) except where that communication is reasonable in all the circumstances, related to their entry or where there is a safety concern or other urgent matter.
- Photograph or video a participant except in accordance with agreed circumstances and commercial providers, or where required for duty of care purposes.
- In the theatre environment or at other times when participants are present, consume alcohol or take illicit drugs under any circumstances.

# **SOCIAL MEDIA POLICY**

**POLICY APPLICATION:** This policy applies to all Committee members and contractors of Bundaberg Regional Eisteddfod Inc. This policy does not apply to Committee members' personal use of social media where no reference is made to Bundaberg Regional Eisteddfod Inc.

**CONSEQUENCE:** Although many users may consider their personal comments posted on social media or discussions on social networking sites to be private, these communications are frequently available to a larger audience than the author may realise. As a result, any online communication that directly or indirectly refers to Bundaberg Regional Eisteddfod Inc or our Annual Eisteddfod

event, Committee members or other event-related issues, has the potential to damage the Bundaberg Regional eisteddfod reputation or interests.

## **POLICY**

This policy has been developed in recognition of the growing popularity of and participation in online social media. The Bundaberg Regional Eisteddfod Inc is supportive of team members participating in social media in their personal time to keep in touch with their friends, share information or become involved in online discussions. However, for members who use social media either as part of their job or in a personal capacity, it is important to understand Committee members' obligations when the online communication is about the Bundaberg Regional Eisteddfod Inc.

The term 'social media' refers broadly to any online media which allows for user participation, interaction or publishing. Commonly used social media tools include, but are not limited to, Facebook, Instagram, YouTube, Twitter and Snapchat.

When participating in social media in a personal capacity, members must:-

- Not disclose Bundaberg Regional Eisteddfod Inc information, proprietary or sensitive information. Information is considered confidential when it is not readily available to the public. If you are in doubt about whether the information is confidential, refer to the Bundaberg Regional Eisteddfod Executive before disclosing any information.
- Not use the Bundaberg Regional eisteddfod logo or association branding on any social media platform without prior approval from the Executive.
- Not communicate anything that might damage the reputation of the Bundaberg Regional Eisteddfod Inc brand image or the confidence of our members.
- Not represent or communicate on behalf of the Bundaberg Regional Eisteddfod Inc in the public domain without prior approval from the Executive.
- Not post any material that would directly or indirectly defame, harass, discriminate against or bully any Bundaberg Regional Eisteddfod member, supplier or supporter.

# PHOTOGRAPHY/PHONE POLICY

# **REGULATION**

The use of photographic devices of any kind are a breach of the privacy laws in accordance with the Child Protection Act.

# PHOTOGRAPHY/PHONE

It is the ruling of the Bundaberg Regional Eisteddfod Committee, that recording of any kind is prohibited.

The Committee regrets that the use of video recorders, cameras, mobile phones or any recording device in the auditorium and side stage area is prohibited.

Official photographers/videographers excepted.

As part of the entry process for each child, permission must be obtained for photos to be distributed through either print media or social media, that is Eisteddfod Facebook page, Local paper and professional media platforms.
